WHO CAN GO WHERE, WHEN AND HOW?

WHO? The access rules are defined individually (in each personnel record) or for a given population.

WHERE? Access can be authorised or refused based on predefined zones.

WHEN? Access rules are defined according to precise timetables and days.

HOW? Using an access card, a code and/or biometric solutions.

Unipass, our access control solution, can automatically determine who can go where, when and under what conditions for an unlimited number of people, card readers and buildings.

You set the rules, and Unipass takes care of making sure they are applied to keep your staff, equipment and documents safe and secure!

Unipass can incorporate autonomous access control with the installation of automatically controlled locking and unlocking systems (locks, cylinders etc.), considerably reducing installation costs.

 - Access rules that can be configured on the fly
